



NEW STORE OPENING SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCE OF WINNING.

AGREEMENT TO THE OFFICIAL RULES. *Participation in the Sweepstakes constitutes full and unconditional agreement to and acceptance of these Official Rules and the decisions of Nordstrom, Inc. (the "Sponsor") which are final and binding in all matters relating to the Sweepstakes and shall not be subject to appeal. All federal, state, and local laws and regulations apply. Void where prohibited. Winning a prize is contingent upon fulfilling all requirements set forth herein.*

1. ELIGIBILITY. The Nordstrom Rack New Store Opening Sweepstakes (the "Sweepstakes") is open only to individuals who are legal residents of, and physically located within, one of the fifty (50) United States, or the District of Columbia, and are at least eighteen (18) years of age or older at time of entry. If a potential winner is at least 18 years old but considered a minor in their jurisdiction of residence, prize may be awarded in the name of their parent/legal guardian who will be responsible for fulfilling all requirements imposed on winner set forth herein. Employees of the Sponsor, its parents, affiliates, and subsidiaries, and each of their respective immediate family members (herein described as spouses, partners, or children and each of their respective spouses/partners, regardless of residence) and any individual living in such a person's household (whether related or not), are not eligible to participate in the Sweepstakes.

2. ENTRY PERIOD AND METHOD. The Sweepstakes begins at approximately 6:00am ET and ends at approximately 8:45am ET on September 3, 2026 ("Entry Period") at Nordstrom Rack Colony Place and 242 Colony Place Plymouth, MA 02360 (the "Participating Store"). To enter: during the Entry Period, submit the completed portion of an official drawing ticket provided by a Nordstrom Rack employee (each, an "Entry Ticket") into the designated entry bin at the Participating Store, keeping the other half of the ticket until after winners have been chosen and confirmed. Sponsor will be the official timekeeper for the Sweepstakes and reserves the right, in its sole discretion and without notice, to modify, cancel, or suspend the Sweepstakes, entry times, or drawing times, if not capable of completion as planned, for any factor beyond Sponsor's control. Limit one (1) Entry Ticket/entry per person. Sponsor is not responsible for and will disqualify entries that are made using anything other than an official Entry Ticket, and/or are ineligible, incomplete, illegible, misdirected, damaged, late, lost, or stolen. Entries become the property of Sponsor and will not be returned. See below section titled "General Conditions" for additional rules regarding entry.

3. WINNER SELECTION AND NOTIFICATION. Starting at approximately 7:00am local time of the Participating Store, and approximately every five (5) minutes thereafter during the Entry Period, one (1) Entry Ticket will be randomly selected from among all eligible entries (each, a "Drawing") and will be immediately announced. The selected Entry Ticket number will be announced up to three (3) times. **TO WIN: ENTRANTS MUST BE PRESENT AT DRAWING, MUST RESPOND BY THE TIME THE THIRD ANNOUNCEMENT HAS BEEN COMPLETED, AND MUST PROVIDE THE MATCHING HALF OF THE DRAWN ENTRY TICKET.**

If a potential winner fails to respond according to the above or, is found to be ineligible or not in compliance with these Official Rules, the prize will be forfeited, an alternate potential winner may be randomly selected from all of the remaining eligible entries, and the above notification process will be repeated.

Each Entry Ticket will be included in every Drawing during the Entry Period at the Participating Store. Selection of an Entry Ticket does not remove that entry from subsequent Drawings. Eligible entrants may win more than once in the Sweepstakes.

4. PRIZE DESCRIPTION AND APPROXIMATE RETAIL VALUE ("ARV"). There will be one (1) confirmed winner per Drawing. Each confirmed winner in the Drawings from 7:00am – 8:40am will have the opportunity to pull one (1) promotional card (each a "Promotional Card") from a bag. If multiple prizes are pulled out at once, the winner must put them back and draw again. Promotional Cards will be in the amounts of \$25.00 and \$50 (ARV of each prize: \$25.00 or \$50.00 USD). PROMOTIONAL CARDS EXPIRE DECEMBER 31, 2026. The confirmed winner of the final Drawing, at approximately 8:45am, will receive one (1) one-thousand dollar (\$1,000.00) Nordstrom gift card (ARV \$1,000.00 USD). Total ARV of all prizes available to be awarded: \$1,800.00 USD.

6. GENERAL PRIZE RESTRICTIONS. Acceptance and use of a gift card or promotional card constitutes acceptance of its terms and conditions.
