

## NORDSTROM NEED-NOW BEAUTY EXCLUSIVES SWEEPSTAKES OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN.

**Eligibility:** The Nordstrom Need-Now Beauty Exclusives Sweepstakes ("Sweepstakes") is open only to legal residents of, and physically located within, the fifty (50) United States/the District of Columbia and Canada, excluding Quebec, age eighteen (18) years or older at time of entry.
