



New Store Opening Gift Card Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: The Nordstrom Rack New Store Opening Gift Card Sweepstakes ("Sweepstakes") is open to legal residents of, and physically located within, the fifty (50) United States or District of Columbia, age eighteen (18) years or older at time of entry. If a potential winner is at least 18 years old but considered a minor in their jurisdiction of residence, prize may be awarded in the name of their parent/legal guardian who will be responsible for fulfilling all requirements imposed on winner set forth herein. All federal, state, and local laws and regulations apply. Employees of Nordstrom, Inc. Sponsor will be the official timekeeper for the Sweepstakes. To enter: during the Promotion Period, submit the completed portion of an official drawing ticket ("Entry Ticket"), provided by a Nordstrom Rack employee, into the designated entry bin at the Participating Store, keeping the other half of the ticket until after a winner has been chosen and confirmed. Limit one (1) Entry per person. Sponsor is not responsible for and will disqualify entries that are misdirected, incomplete, illegible, damaged, late, or lost. No automatic, robotic, mechanical entries or reproductions accepted. Entries become the property of Sponsor and will not be returned. 3. Prizes; Values; Odds: One (1) winner will receive one (1) \$1,000.00 USD Nordstrom Rack gift card (ARV \$1,000.00 USD). Total ARV of all prizes: \$1,000.00 USD. The actual value of a prize awarded may be taxable as income, and any applicable taxes and all other costs/expenses/fees not specifically stated herein are the sole responsibility of a winner. If the potential winner fails to respond within five (5) minutes from the Announcement, or the potential winner is found to be ineligible or not in compliance with these Official Rules, prize will be forfeited, and an alternate potential winner will be randomly selected from all of the remaining eligible entries.
